Standing Rules for Covenant Presbytery

1.00 General Regulations

- **1.10 NAME:** The name shall be "Covenant Presbytery," hereafter called "The Presbytery."
- **1.20 DENOMINATIONAL AFFILIATION:** The Presbytery is a governing body of the Cumberland Presbyterian Church and is a member of the Synod of the Midwest.
- 1.30 BOUNDRIES: The Presbytery includes Hopkins, Trigg, Henderson, Webster, Union and all counties that lie west of them in Kentucky including areas of Christian County five miles in diameter around the Hopkinsville Church and a corridor three miles wide along the little river, westward to the Trigg County line. The Presbytery also includes the following counties in Illinois: Alexander, Hardin, Jackson, Johnson, Massac, Pope, Pulaski, Saline, Union, and Williamson with the exception of the Lebanon South Church, one mile north of Galatia.
- **1.40 MEMBERSHIP:** The Presbytery consists of its ordained ministers, and all Cumberland Presbyterian churches located within its boundaries.
- **1.50 MANUAL OF OPERATION:** The Presbytery shall use the "Presbytery Manual of Operation" as a guideline for matters that are not covered by these Standing Rules.
- **1.60** SUSPENSION OF, OR AMENDMENTS TO THE STANDING RULES: These Standing Rules may be suspended or amended by a two-thirds vote of those present and voting.
- **1.70 BOARD OR COMMITTEE RECOMMENDATIONS:** Any board or committee making recommendations to the Presbytery shall indicate in their report any recommendation requiring a 2/3 vote for passage.

2.00 MEETINGS

- **2.10 DATE AND TIME:** The Presbytery shall convene in 2 regular meetings which shall be on the third Saturday of March and the third Saturday of September at 9:00 a.m. When the March meeting date falls in Holy Week, that meeting shall be delayed 1 week. The Presbytery shall also have such adjourned and called meetings as necessary.
- **2.15 WORSHIP:** Each stated meeting of Presbytery shall open with a worship service which includes a ten (10) minute devotional by the moderator and serving of Communion. After each noon recess the meeting shall be reopened with a ten (10) minute devotional led by a probationer designated by the Committee on the Ministry.
- **2.20 PLACE:** The place of all regular meetings of the Presbytery shall be chosen by invitation from the member churches.
- **2.30 ATTENDANCE:** All ordained ministers (other than those who have been permanently excused,) probationers, and elder delegates from each church in the Presbytery are expected to attend each meeting of Presbytery. If for a valid reason one is unable to attend, an excuse should be sent to the stated clerk requesting an excuse and stating the reason.
- **2.40 ENROLLMENT:** Prior to each regular meeting of Presbytery, the moderator shall appoint a Credentials Committee. During the period of registration thirty minutes prior to the stated time for the meeting, the committee will receive and certify the enrollment cards. Their report to the body, at the time set on the agenda, will serve as the opening roll call for the determination of a quorum.
- **2.50 AGENDA:** The agenda for each meeting of the Presbytery shall be prepared by the moderator, stated clerk, and pastor host.

2.60 HOST CHURCH: The host church shall be reimbursed \$200 for each stated meeting of the Presbytery.

3.00 OFFICERS

- **3.10 MODERATOR:** The moderator shall be elected for a one year term and shall serve until a successor is elected. The moderator shall serve as an advisory member of all Presbytery boards and agencies. See the Presbytery Manual of Operation, Section 3.1 and the Rules of Order, Section 1. The moderator shall appoint someone to fill vacancies on boards and agencies until the next stated meeting. Prior to the stated meetings of Presbytery, the moderator shall appoint a Committee on Overtures and Resolutions to serve during the meeting.
- **3.20 VICE-MODERATOR:** The vice-moderator shall be elected for a one year term and shall serve until a successor is elected. It is expected that the vice-moderator shall succeed the moderator, but this is subject to the will of the Presbytery. See the Presbytery Manual of Operation, Section 3.2 and the Rule of Order, Section 2.
- 3.30 STATED CLERK/TREASURER: The stated clerk/treasurer shall be elected for a three year term and may serve additional terms. The stated clerk may or may not be a member of the Presbytery. The stated clerk shall be an advisory member of all Presbyterial boards and agencies and in this capacity, serve the Presbytery as liaison for planning and budgeting. The stated clerk must be bonded and may not disburse any funds without proper authorization from the Presbytery. The stated clerk shall reimburse members of boards and agencies at the official mileage rate allowed by the Internal Revenue Service, adjusting the rate on January 1st each year. Preliminary minutes, containing the agency reports and other relevant materials, shall be prepared by the stated clerk and sent to all ministers, probationers, and session clerks at least 15 days before stated meeting of Presbytery. All ministers, elder delegates, probationers, session clerks, agency members, CPWM officers, and other denominational entities who request them shall have electronic or paper copies of Presbytery minutes distributed to them. The minutes shall include a directory of ministers, probationers, church (with location), session clerks, agency personnel and the name of the church moderator for all churches without an ordained Cumberland Presbyterian pastor. Electronic copies shall be made available within 60 days from the stated meeting for those requesting that medium of distribution. Paper copies of minutes will be printed and mailed annually to include all meetings within that year.
- **3.40 RECORDING CLERK:** The recording clerk shall be elected for a three-year term and may serve additional terms. The recording clerk may or may not be a member of the Presbytery. The recording clerk shall record the minutes of the meetings and assist the stated clerk in preparing the minutes for printing.
- **3.50 TRUSTEES:** The members of the Board of Finance shall be the trustees for the Presbytery. The trustees shall be the legal agents of the Presbytery and shall act in that capacity when so directed by the Presbytery.

4.00 AGENCIES

- **4.10 DATE, TIME, PLACE OF REGULAR MEETING:** All standing agencies of the Presbytery shall convene for their regular meeting at 9:00 a.m. six (6) Saturdays previous to the regular meeting of Presbytery, at the host church.
- **4.15 AGENCY RESPONSIBILITIES:** For agency responsibilities not covered in these standing rules, refer to the "Presbytery Manual of Operation," approved by the 1988 General Assembly, and published by the office of the Stated Clerk of the General Assembly.
- **4.20 MEMBERSHIP BALANCE:** In electing members to Presbyterial agencies, care should be taken to maintain approximately a fifty-fifty balance of ministers and laypersons. There should be an appropriate male/female ratio and a fair geographic representation.
- **4.25 REPORTS OF BOARDS AND AGENCIES:** Reports of all boards and agencies shall be submitted to the stated clerk no later than four (4) Saturdays previous to the regular meeting of Presbytery.
- **4.30 BOARD OF MISSIONS:** The board shall consist of nine members in three staggered terms. The president of the Regional Cumberland Presbyterial Women's Ministry shall be an advisory member of this board.
- **4.31 TERM OF OFFICE:** The term of office shall be for three years, and members may not serve more than three consecutive terms.
- **4.32 RESPONSIBILITIES:** The Presbyterial Fellowship and the Regional Cumberland Presbyterial Women's Ministry will be under the supervision of this board and shall channel their reports to the Presbytery through it. The board will maintain a file of all pastoral contracts, including both stated supply and installed relationships. The board will appoint moderators for all sessions not served by ordained Cumberland Presbyterian Ministers. For other responsibilities refer to the "Presbytery Manual of Operations," Section 5.25.
- 4.33 Any commission to install pastors must include at least one member from the Board of Missions.
- 4.34 Upon the closing of a church in Covenant Presbytery, the session clerk of the closed church is to be responsible to forward a complete membership roll of that congregation to the session clerk of the church specified to have the members attached to it.
- **4.35 BOARD OF CHRISTIAN EDUCATION:** The board shall consist of nine members in three staggered terms.
- **4.36 TERMS OF OFFICE:** The term of office shall be three years, and members may not serve more than three consecutive terms.
- **4.37 RESPONSIBILITIES:** The board shall be responsible for planning, promoting, and conducting the Presbyterial camping program, including retreats and conferences for all ages.

The board oversees sponsoring the ongoing youth fellowship program in Covenant Presbytery and encouraging the youth programs in the local churches.

The entire Christian Education Program of the congregations of Covenant Presbytery should be of concern by the board as they plan workshops, seminars, etc. to assist and encourage the local churches.

- **4.40 BOARD OF FINANCE:** The Board of Finance shall consist of nine members in three staggered terms.
- **4.41 TERM OF OFFICE:** The term of office shall be for three years, and members may not serve more than three consecutive terms.
- **4.42 PRESBYTERY BUDGET:** The Presbytery budget shall be a percentage of the current income received by the churches to be equal to the proposed budget. Income is the total amount that is given through the church and Sunday school treasuries. Exemptions are:
 - 1. Money raised by the Youth Fellowship, CPWM, Men's Fellowship, and other auxiliaries of the church.
 - 2. Memorial gifts.
 - 3. Money that is borrowed by the church.
 - 4. Gifts that are designated by the donor for a specific purpose such as the purchase of an organ.
 - 5. Building fund money that goes toward the erection of a new sanctuary, church addition, or manse.

Regular maintenance that does not produce additional space, including remodeling, is not exempt.

Churches shall remit payments on apportionments to Presbytery on a monthly basis. Churches experiencing circumstances preventing timely payment of assigned percentage, shall contact the Board of Finance for possible assistance and to allow the board sufficient information for planning purposes.

- **4.42.1 COVENANT PRESBYTERY NEW CHURCH DEVELOPMENT FUND:** This fund shall receive all proceeds from property sold by Covenant Presbytery. Expenditures from this fund shall be restricted to grants made to official NCD projects within Covenant Presbytery for the purpose of purchasing property and/or building programs. Available funds in the account, not in immediate need, may be loaned as an "on demand loan" to congregations within Covenant Presbytery for building and/or remodeling.
- **4.43 RESPONSIBILITIES:** The Board of Finance and their successors in office shall be the trustees of the Presbytery.

The board shall encourage the churches to give full support to the Presbytery and Synod budget and the Denominational "Our United Outreach" (OUO).

The board, in cooperation with the Board of Christian Education and the Board of Missions, shall plan, publicize, and implement seminars on stewardship, and utilize other means to develop good stewardship practices within the congregations of the Presbytery.

The board shall be the agency responsible for the maintenance of the Presbytery's physical assets such as real estate, office equipment, etc.

The board shall oversee the program of ministerial aid to needy ministers and minister's widows.

The board shall receive the proposed budgets of the other agencies, amending them as necessary, and submitting one unified budget to the Presbytery for action.

The board shall receive loan applications from churches in the Presbytery, making recommendation to the Presbytery concerning these requests.

All requests to the Presbytery for additional funding beyond the approved annual budget shall be directed to the Board of Finance for review, determination, and recommendation to Presbytery at any subsequent meeting.

(In an emergency the Board of Finance shall be endowed with the authority and responsibility of funding from surplus funds, the needs created by any such emergency. – action of Presbytery 4/7/01)

- **4.45 COMMITTEE ON MINISTRY:** The committee shall consist of nine members in three staggered terms. The committee shall include both ministers and laypersons with at least two members being elders.
- **4.46 TERM OF OFFICE:** The term of office shall be three years, and members may not serve more than three consecutive terms.
- **4.47 RESPONSIBILITIES:** The committee shall direct and nurture persons in preparation for the ministry. Those considering becoming candidates for the ministry shall be interviewed by the committee prior to their appearance before the Presbytery.

The committee also has responsibilities relating to the persons and ministries of the ordained ministers of the presbytery.

Any contractual pastoral relationship in Covenant Presbytery who is not an ordained CP minister or who is not an approved candidate for CP ministry should meet with and /or communicate with the COM prior to filling the pulpit.

There is an extensive description of the duties and responsibilities of the Committee on Ministry in the "Presbytery Manual of Operation," Section 5.4.

- **4.50 JUDICIARY COMMITTEE:** The committee shall consist of nine members in three staggered terms.
- **4.51 TERM OF OFFICE:** The term of office shall be three years, and members may not serve more than three consecutive terms.
- **4.52 RESPONSIBILITIES:** The committee shall review annually the session records of the churches and report its findings and recommendations to the presbytery. The session clerks shall send the session records for the previous year (or a certified copy) to the Judiciary Committee at the time and place specified by said committee.

The committee shall study all questions coming before the presbytery by appeal, dissent, or protest, and advise the presbytery on their legal and constitutional aspects. The committee shall make rulings on such judicial questions as are referred to it.

The committee shall impose discipline when a minister acknowledges to the Judiciary Committee an error or offense and consents to the discipline proposed by the committee. If the minister acknowledges the error or offense, but does not consent to the discipline, the Judiciary Committee must refer the matter back to the Disciplinary Commission.

The committee shall hold a hearing (following the directions set forth by the General Assembly) to determine guilt and, if appropriate, impose discipline in those cases where the minister does not acknowledge guilt and consent to discipline. The committee shall report its actions to presbytery. (This is a report only, not a recommendation to be voted upon by presbytery.)

The committee shall conduct a supplemental hearing upon a minister's request if new evidence is discovered. After a hearing, the committee may restore a minister who has been suspended or deposed if he or she meets the criteria of Rule 3.415.

The committee will hear and decide appeals from sessions under the presbytery's jurisdiction, and give a report of appeals to the presbytery.

- **4.55 HERITAGE COMMITTEE:** This committee has been dissolved and will be reactivated if the need arises.
- **4.60 COMMITTEE ON NOMINATIONS:** The committee shall be composed of six (6) members in three staggered terms.
- 4.61 TERM OF OFFICE: The term of office shall be three years and members will not be eligible to succeed themselves. Members of this committee may NOT serve on the Permanent Nominating Committee and other agencies concurrently. Members of this committee shall not be consecutively nominated to another agency. A member appointed or elected to fill the unexpired term of another person shall be eligible to serve a three-year term after completion of the unexpired term. The members should include at least one (1) minister and two (2) lay persons.
- 4.62 **RESPONSIBILITIES:** The committee shall make nominations to the October meeting of Presbytery: names to fill all vacancies on Presbyterial agencies, commissioners to General Assembly and their alternates, youth delegates to General Assembly and the alternate, delegates to Synod and their alternates, and youth delegates to the Cumberland Presbyterian Youth Conference (CPYC) and their alternate.

 The Committee on Nominations should be especially sensitive to the need for including
 - The Committee on Nominations should be especially sensitive to the need for including fair representation on all agencies and in all positions. (See standing rule 4.20.)

4.63 COMMISSIONERS TO GENERAL ASSEMBLY AND DELEGATES TO SYNOD:

Election of General Assembly commissioners: The Presbytery shall elect one minister commissioner and one elder commissioner for every 1,250 active members on its roll as its commissioners to General Assembly. See Section 9.2 of the Cumberland Presbyterian Constitution.

The election of commissioners to General Assembly will be as follows: three (3) commissioners on the part of the ministry and three (3) commissioners on the part of the elders shall be elected. Three (3) ministers and three elders shall be elected and listed in a 1, 2, 3 order to serve as alternate commissioners in the event any of the principle commissioners are unable to attend General Assembly.

The election of delegates to Synod will be as follows: three (3) delegates on the part of the ministry and three (3) delegates on the part of the elders shall be elected. Three (3) ministers and three (3) elders shall be elected and listed in a 1, 2, 3 order to serve as alternate delegates in the event any of the principle delegates are unable to attend Synod.

Reports from the commissioners to General Assembly and the delegates to Synod shall be given at the fall meeting of Presbytery.

- **4.65 <u>DISCIPLINARY COMMISSION:</u>** The commission shall be composed of five (5) members elected on staggered terms.
- **4.66 TERM OF OFFICE:** The term of office shall be three years, and members may not serve more than three consecutive terms.

4.67 RESPONSIBILITES: The commission shall receive complaints made in writing from the victim or a person with reliable and compelling information or from the stated clerk of presbytery who has received the written complaint from one of the above persons.

The commission shall conduct an appropriate investigation of any written complaint. The commission shall not decide innocence or guilt. They investigate to determine if there is enough evidence for a hearing.

If the Disciplinary Commission, upon investigation, finds no basis for the charges, it shall close the matter and report that action to the accused, the complainant, and the Judiciary Committee.

If the commission finds that there are grounds to believe that an offense was committed by the accused, and the accused acknowledges the error or offense and gives evidence of a sincere effort to correct the matter, the commission shall so report to the Judiciary Committee and recommend appropriate disciplinary action.

If, upon investigation, the Disciplinary Commission determines that "there are grounds to believe that an offense was committed by the accused," they will refer the matter for a hearing before the Judiciary Committee. At this time, the commission should (1) appoint 1-3 members to represent the Disciplinary Commission in the hearing process (2) make a complete report of the investigation to the Judiciary Committee.

If the charges concern matters of potentially serious consequences, the Disciplinary Commission may at any time place limitations on the person's ministry or suspend the person from any position of ministry until the conclusion of the hearing and of any appeals.

If necessary, the Disciplinary Commission may appeal a disciplinary decision of the Judiciary Committee.

The commission may informally counsel a minister if there is an unwritten complaint against him or her.

4.70 INSURANCE COMMISSION:

- 4.71 TERM OF OFFICE:
- **4.72 RESPONSIBILITES:** The commission shall deal with all presbyterial insurance needs and transactions including pastoral insurance.

5.00 OPERATING GUIDELINES

- **5.10 FINANCIAL REPORT:** The treasurer shall prepare a detailed annual report at the end of each fiscal year (calendar year), quarterly reports during the fiscal year, and such supplemental reports as the agencies of the Presbytery may need. The treasurer shall present the financial reports for an annual audit by a three person audit committee appointed by the Board of Finance each year.
- MEMORIAL ROLL: A memorial roll of deceased ministers and elders shall be carried in the Presbytery minutes each year. The stated clerk shall purchase a one hundred dollar Patron Membership in Theological Education in the name of each deceased minister. Also, the same patron membership is to be purchased for each deceased elder who has served as moderator of Covenant Presbytery. The certificates for the patron memberships shall be presented to the families of the deceased (or representative of the family) at the next regular meeting of Presbytery.
- **5.30 PRESBYTERY YEAR:** The Presbytery year shall follow the calendar year, January 1 through December 31.
- **5.40 NEW BUSINESS:** All resolutions, memorials, and other items of new business must be presented prior to the noon recess of the meeting of Presbytery.
- **5.50 CONDUCT OF MEETINGS:** All meetings of the Presbytery shall be conducted according to the Rules of Order of the Cumberland Presbyterian Church. Any case not covered by these rules shall be governed by the current edition of Robert's Rules of Order.
- 5.60 **INFORMATION REPORT:** A form for churches to submit information needed by the agencies of the Presbytery will be available at the April meeting each year. The session clerk shall send this information to the stated clerk's office by August 1st each year.

Appendix B A Memorial on the Dignity of the Unborn

Whereas, God knows us before we are born Jeremiah 1:5

Whereas, Ministers in our denomination early in our denomination witnessed to and prayed for mothers who have lost children.

Whereas, the view "rare but legal" was the prominent left leaning view in the 1990's.

Whereas, there are more contemporary views on abortion which celebrate abortion as reproductive rights, rather than view it as a sad tragedy which is either chosen due to circumstances or necessitated by lifesaving methods of the mother or quality of life of the child (severe deformity, etc.)

Be it Resolved that The Cumberland Presbyterian Church and the Cumberland Presbyterian Church of America do not celebrate abortion, rather we uphold life. We resolve that any sacrifice of life of an unborn child is not to be celebrated, but to be mourned. Those who feel they must make that horrific and difficult choice should know we are there to minister to these women: 1. Women who because of the possible loss of their life, save their own and abort the baby; 2. Women, who because of severe deformity of the child, make the hard decision to end the child's life; 3. Women or children who are victims of rape and have to commit a heinous act on the unborn child's body after one was already done to theirs; 4. Women who feel abortion is a reasonable contraception option and terminate life on the premise that it is not a baby within their womb and it is.

May we witness and testify Jesus Christ to the people broken by the realization of what they have done; may we the Cumberland Presbyterian Church, with varying views on abortion, never celebrate the death of an infant, rather, may we gather around families who have made hard choices and pick up the pieces of this tragic procedure, offering love and care to those who mourn, and restorative care in the name of our savior, Jesus Christ.

To: Covenant Presbytery in session with Sturgis Church, September 21, 2024.

The Grace Covenant Commission submits the following report and recommendations:

In the spring meeting of Covenant Presbytery, presbytery named a commission to address the critical situation of Grace Covenant Church. GCC has suffered a significant decline in membership, finances, as well as the recent departure of Rev. Bernice Belt.

Commission members are:

- o Rev. Jim Smith, chairman
- Rev. Dr. Chris Fleming, member, Dir. of "Engaged" Program, and longtime GCC pastor
- o Rev. Bud Russell
- o Rev. Brad Henson
- o Elder Tanner Parker
- Elder Logan Blewett
- o Elder Chris Burkhart
- Elder Reese Baker, Stated Clerk of Covenant Presbytery

The commission's first meeting was May 9, 2024, 11:00 am. The first two meetings were held in person and at Grace Covenant Church. The meetings that followed were by zoom. Each meeting had a quorum, started with prayer, and ended with adjourning prayer.

This chairman, as well as all commission members, would like to assert the crucial contribution of Wendy Weaver, GCC secretary, throughout this challenging process.

The following is a condensed summary of the commission's work and actions to date:

I. Initial evaluation of GCC's circumstances revealed there are not enough funds, not enough members, and not enough time to provide for effective assessment, programming, and execution of programming that would attain, maintain, sustain, or support future growth of the church, and in the short amount of time needed. To reach even a minimum baseline for substantiating further presbyterial financial and other assistance, Rev. Fleming, commission member and Director of the "Engaged" Program, amplified this conclusion. Furthermore, there were not enough ordained elders to maintain a quorum and conduct business.

Elders Logan Blewett and Chris Burkhart - both being commission members and elders of Grace Covenant Church - provided direct input from the congregation about all aspects mentioned above. Elder Blewett maintained that the congregation unanimously

agreed they did not want to leave the church building and were intent on "rolling up their sleeves."

- II. The commission established that regardless of the future of the church, the worshipping congregation needed to vacate the building as soon as possible. Reverend Brad Henson proposed establishing a relationship with the Grace Covenant congregation whereby they would be yoked with Woodlawn Church. The Grace Covenant congregation however would continue as a "worshipping community" (per the definition found in the *Confession of Faith*).
- III. The Grace Covenant congregation agreed to schedule a congregational meeting per the appropriate guidelines of the *Confession of Faith*. Rev. Brad Henson and Rev. Jim Smith, acting meeting moderator, met with the church congregation following the worship service on June 16th, Father's Day. There were 9 people in attendance. Rev. Henson presented a program that would potentially provide for all the needs of the congregation and would achieve the immediate goal of vacating the building, allowing for the future possibility of returning to the church building.

After the presentation, Rev. Smith explained the process of voting. Reverend Smith explained to the congregation that - per the earlier decision of the commission - a negative vote would prompt the closure of the Grace Covenant Church. Reverend Smith called for the vote. It took four attempts to reach a final vote.

- IV. The commission has since begun the process of disposition of the building and its contents. The commission met on zoom with Mr. Zack Bishop from House of Worship, a company specializing in media and sound for churches. The company expressed a need for a facility in Paducah for storage, demonstrations, etc. Mr. Bishop also expressed the idea of future work with the Cumberland Presbyterian Churches of Covenant Presbytery in sound design. The commission met July 26th by zoom to discuss the offer by the company to lease the Grace Covenant Church building. The commission is currently determining a fair lease amount that would mean a wash to the presbytery in terms of monthly expenses of maintaining the building.
- V. The commission held a zoom meeting on August 22, 2024, at 11 a.m. All commission members were present. Also, present were the Board of Finance representatives, Raymond Nelson and Rev. Curtis Franklin. The commission action:
- 1. Finished review of offer by House of Worship and Zack Bishop to lease the Grace Covenant Church building.
- 2. Reviewed research by Rev. Fleming and Rev. Henson on monthly expenses for the church building, as well as implications for insurance coverage.

- 4. Based on all input, the commission as well as BOF representatives determined that further ownership of the church building was not at all feasible, and, in fact, was a significant liability.

- 5. Consequently, a recommendation was made and seconded to transfer all business, finance, and disposition of property over to the Presbyterial Board of Finance. Motion passed.
- 6. All members of the Grace Covenant Church Commission agreed that the purpose of the commission had been completed. Motion made and seconded to terminate the commission with blessings for the hard work of all involved.

<u>Recommendation #1</u>: Having completed the task before them that the Grace Covenant Commission be dissolved.

The commission also voices great appreciation and gratitude for the work of Wendy Weaver. Mrs. Weaver has always poured her heart, her abilities, and her faith into her work as church secretary for both the Margaret Hank and Grace Covenant Cumberland Presbyterian Churches. She was also invaluable in the bittersweet work of the commission as it sought God's direction and will for Grace Covenant Cumberland Presbyterian Church.

Committee to Reach Out to Likeminded Presbyteries

To: Covenant Presbytery in Zoom session, October 19, 2024.

The Committee to Reach Out to Likeminded Presbyteries submits the following letter:

Dear Brothers & Sisters in Christ,

Grace and peace to you in the name of Jesus Christ. Perhaps the most difficult thing that any church/denomination must do is exercise discipline. The Reformers held that there were three essential pillars of the church. The faithful preaching of God's Word, the administration of the sacraments, and church discipline. Therefore, if we call ourselves "reformed" we must, however difficult, exercise church discipline. At the 193rd meeting of General Assembly we asserted the following:

- 1. Asserting that the Confession of Faith and the Constitution do not contain nonessentials.
- 2. Interpreted the constitution (Const. 9.4c) by clearly answering the following questions regarding the oaths taken during the ordination of elders/deacons (2.92) and ministers (6.36) and adding the assembly's interpretive rulings to the Cumberland Presbyterian Digest.
- 3. Confirmation of the necessity of disciplining ministers who willingly and openly preach and teach against our doctrine.

It was clear from the majority's response at the General Assembly that we, as a denomination, must stand upon the Word of God as well as our Confession of Faith, which states: COF 6.17 Marriage is between a man and a woman for the mutual benefit of each, their children, and society. While marriage is subject to the appropriate civil law, it is primarily a covenant relationship under God. As such, it symbolizes the relationship of Jesus Christ and the church, and is that human relationship in which love and trust are best known.

God's Word compels us to remain steadfast in our convictions and maintain the purity of Christ's church. Those who preach or teach contrary to the Word of God and/or the Confession of Faith from the pulpit or any other place within the church cause confusion and lead God's people astray. Therefore, any failure on our part to practice church discipline undermines the gospel of Jesus Christ. As it says in 2 John 1:7b, "If anyone comes to you and does not bring this teaching [the gospel as given in the God's Word] do not receive him into your house or give him any greeting, for whoever greets him takes part in his wicked works. (2 John 1:7, 10-11 ESV)

In order for the church of Jesus Christ to be a witness to the watching world it is imperative that we do not allow the church to simply go along to get along with the teachings of the sinful world which promote sinful practices as clearly expressed in God's Word. Scripture tells us in 1 Corinthians 6:4, 9-11, "So if you have such cases, why do you lay them before those who

have no standing in the church? ... Or do you not know that the unrighteous will not inherit the kingdom of God? Do not be deceived: neither the sexually immoral, nor idolaters, nor adulterers, nor men who practice homosexuality, nor thieves, nor the greedy, nor drunkards, nor revilers, nor swindlers will inherit the kingdom of God. And such were some of you. But you were washed, you were sanctified, you were justified in the name of the Lord Jesus Christ and by the Spirit of our God." (ESV)

In light of the clear teaching of God's Word as well as the affirmation of the 193rd General Assembly, disciplinary action should be taken against anyone who preaches or teaches contrary to our *Confession of Faith*. Additionally, the Rules of Discipline state the following: *Discipline in the church is a positive expression in the spirit of love and helpfulness of concern both for the offender and for the church. Its purpose is that the life and work of the church may be orderly, conducive to the spiritual growth of the members, and corrective of weaknesses, mistakes and offenses by individuals and judicatories. Appropriate reasons for discipline are actions contrary to the faith and practice to which, according to the scriptures, all Christians are called, or which are contrary to the government of the church. (Rules of Discipline 1.1)*

Covenant Presbytery stands united in this matter. The purpose of this letter is to encourage other presbyteries to take action and prepare to safeguard the purity of God's church.

In order to achieve this in accordance with our polity, certain steps must be taken. The steps are as follows:

- 1. A church within a presbytery with divisions or heretical teaching must immediately take disciplinary action by filing charges against the offending session and its minister. When the action of a particular church is detrimental to the spiritual welfare of its members or to the connectional relations and ministries of the larger church, it shall be counseled by the board of missions of the presbytery or by a special committee or commission appointed by the presbytery. Should counseling fail to achieve the desired objective, the presbytery may admonish the church and instruct its session to correct what is wrong, suspend the session and govern the church temporarily through a commission, dissolve the session and conduct a new election of elders, or dissolve the church and attach its members to other congregations. (Rules of Discipline 2.3)
- 2. If disciplinary action at the presbytery level fails, then an appeal must be made to the synod. It is essential for those at the synodic level to remember that presbyteries are responsible for ensuring the outcomes of the General Assembly are implemented. As our constitution states: *Presbytery must see that the injunctions of the higher judicatories are obeyed.* (Constitution 5.6h). The Constitution also states: Should a judicatory neglect to perform its duty, and thereby allow false doctrine or immorality to develop, offenders to go undisciplined, or other great irregularities to occur and not be properly recorded, the higher judicatory being aware by other means that such neglect or irregularity has occurred, shall make inquiry into and shall examine, deliberate, and decide the entire matter as if it had been recorded, and thus brought up by review and control. (Constitution 4.104)

The responsibility and authority for discipline of their constituent judicatories by synods and the General Assembly is exercised in general review and control, or in response to an appeal of an action taken by a constituent judicatory. When the action of a constituent judicatory is contrary to the rules of government of the church or detrimental to the connectional relations or life and ministries of the church, it may be counseled through a special committee or commission, admonished, suspended, instructed to correct what is wrong, or dissolved. (Rules of Discipline 2.4)

- 3. If the Synod fails to take appropriate action, appeals should be made to General Assembly. The responsibility and authority for discipline of their constituent judicatories by synods and the General Assembly is exercised in general review and control, or in response to an appeal of an action taken by a constituent judicatory. When the action of a constituent judicatory is contrary to the rules of government of the church or detrimental to the connectional relations or life and ministries of the church, it may be counseled through a special committee or commission, admonished, suspended, instructed to correct what is wrong, or dissolved. (Rules of Discipline, 2.4)
- 4. If General Assembly fails to perform its duties to protect the doctrine and purity of the church as stated in our confession, then it will become necessary to enact discipline upon the judiciary committee. Our constitution states: The General Assembly has oversight and responsibility to: Receive and decide all appeals, protests, and referrals regularly brought before it from the lower judicatories; Bear testimony against error in doctrine and immorality in practice, injuriously affecting the church; Decide in all controversies respecting doctrine, discipline, church property, and interpretation of the Constitution. (Constitution 9.4)

A member of the judiciary committee is prohibited from going against the Confession of Faith or the Constitution. By overturning disciplinary actions taken against pastors, sessions, or churches who openly disregard our Confession of Faith, the committee is directly violating the Confession of Faith and the General Assembly's ruling concerning its interpretation. Several examples include: the provision of same-sex marriages by pastors or allowing elders who are in same-sex marriages to serve on the session at a particular church and as delegates to the presbytery. When the committee fails to adhere to our Confession of Faith, it is out of order. A memorial may be submitted to the General Assembly for the removal of members of the judiciary committee. In the event that we reach this point, we must pursue discipline to the fullest extent permitted by our polity.

Finally, Covenant Presbytery would like to encourage ministers, elders, churches, and individuals to proclaim God's Word boldly. Despite challenges and opposition, remain committed to the purity of Christ's church. We will prevail because Christ's church will prevail! (Matthew 16:18) Our commitment to biblical values must remain unwavering. In order to stand firm on the foundation of truth that has stood the test of time, we must be bold in our faith. It is likely that we will be accused of being unloving as we take this stand. We will be accused of failing to maintain the unity of the church. Brothers and sisters, nothing could be further from the

truth. Unity is only possible when it is founded on the clear teachings of God's Word. A failure to discipline those who depart from the truth of God's Word is unloving.

For the moment all discipline seems painful rather than pleasant, but later it yields the peaceful fruit of righteousness to those who have been trained by it. (Hebrews 12:11 ESV)

Possible Points of Action to Prayerfully Consider:

- Direct your donations to ministries both inside and outside the denomination that are following God's Word and adhering to our Confession of Faith. By doing this we support the spread of the Gospel of Jesus Christ as well as make a financial statement to those who contradict the Word of God.
- A congregational meeting should be organized to inform all members (not just the session) of the current state of our denomination. In order for our members to be effective, we must equip them with knowledge of God's Word as well as information regarding the current state of affairs within our denomination.
- Attend meetings of your presbytery, synod, and General Assembly. Do not allow those who propagate these heresies to become voting members of the body when you could have voted against them
