# Standing Rules for Covenant Presbytery

# 1.00 General Regulations

- NAME: The name shall be "Covenant Presbytery," hereafter called "The Presbytery." 1.10
- DENOMINATIONAL AFFILIATION: The Presbytery is a governing body of the Cumberland Presbyterian Church and is a member of the Synod of the Midwest. 1.20

۴

- BOUNDRIES: The Presbytery includes Hopkins, Trigg, Henderson, Webster, Union and all counties that lie west of them in Kentucky including areas of Christian County 1.30 five miles in diameter around the Hopkinsville Church and a corridor three miles wide along the little river, westward to the Trigg County line. The Presbytery also includes the following counties in Illinois: Alexander, Hardin, Jackson, Johnson, Massac, Pope, Pulaski, Saline, Union, and Williamson with the exception of the Lebanon South Church,
- MEMBERSHIP: The Presbytery consists of its ordained ministers, and all Cumberland Presbyterian churches located within its boundaries. 1.40
- MANUAL OF OPERATION: The Presbytery shall use the "Presbytery Manual of Operation" as a guideline for matters that are not covered by these Standing Rules. 1.50
- SUSPENSION OF, OR AMENDMENTS TO THE STANDING RULES: These Standing Rules may be suspended or amended by a two-thirds vote of those present and 1.60
- BOARD OR COMMITTEE RECOMMENDATIONS: Any board or committee making recommendations to the Presbytery shall indicate in their report any 1.70 recommendation requiring a 2/3 vote for passage.

#### 2.00 MEETINGS

- DATE AND TIME: The Presbytery shall convene in 2 regular meetings which shall be on the third Saturday of March and the third Saturday of September at 9:00 a.m. When 2.10 the March meeting date falls in Holy Week, that meeting shall be delayed 1 week. The Presbytery shall also have such adjourned and called meetings as necessary.
- WORSHIP: Each stated meeting of Presbytery shall open with a worship service which includes a ten (10) minute devotional by the moderator and serving of Communion. 2.15 After each noon recess the meeting shall be reopened with a ten (10) minute devotional led by a probationer designated by the Committee on the Ministry.
- The place of all regular meetings of the Presbytery shall be chosen by 2.20 invitation from the member churches.
- ATTENDANCE: All ordained ministers (other than those who have been permanently excused,) probationers, and elder delegates from each church in the Presbytery are 2.30 expected to attend each meeting of Presbytery. If for a valid reason one is unable to attend, an excuse should be sent to the stated clerk requesting an excuse and stating the
- ENROLLMENT: Prior to each regular meeting of Presbytery, the moderator shall appoint a Credentials Committee. During the period of registration thirty minutes prior to 2.40 the stated time for the meeting, the committee will receive and certify the enrollment cards. Their report to the body, at the time set on the agenda, will serve as the opening roll call for the determination of a quorum.
- AGENDA: The agenda for each meeting of the Presbytery shall be prepared by the 2.50 moderator, stated clerk, and pastor host.

**2.60 HOST CHURCH:** The host church shall be reimbursed \$200 for each stated meeting of the Presbytery.

#### 3.00 OFFICERS

- 3.10 MODERATOR: The moderator shall be elected for a one year term and shall serve until a successor is elected. The moderator shall serve as an advisory member of all Presbytery boards and agencies. See the Presbytery Manual of Operation, Section 3.1 and the Rules of Order, Section 1. The moderator shall appoint someone to fill vacancies on boards and agencies until the next stated meeting. Prior to the stated meetings of Presbytery, the moderator shall appoint a Committee on Overtures and Resolutions to serve during the meeting.
- **3.20 VICE-MODERATOR:** The vice-moderator shall be elected for a one year term and shall serve until a successor is elected. It is expected that the vice-moderator shall succeed the moderator, but this is subject to the will of the Presbytery. See the Presbytery Manual of Operation, Section 3.2 and the Rule of Order, Section 2.
- 3.30 STATED CLERK/TREASURER: The stated clerk/treasurer shall be elected for a three year term and may serve additional terms. The stated clerk may or may not be a member of the Presbytery. The stated clerk shall be an advisory member of all Presbyterial boards and agencies and in this capacity, serve the Presbytery as liaison for planning and budgeting. The stated clerk must be bonded and may not disburse any funds without proper authorization from the Presbytery. The stated clerk shall reimburse members of boards and agencies at the official mileage rate allowed by the Internal Revenue Service, adjusting the rate on January 1st each year. Preliminary minutes, containing the agency reports and other relevant materials, shall be prepared by the stated clerk and sent to all ministers, probationers, and session clerks at least 15 days before stated meeting of Presbytery. All ministers, elder delegates, probationers, session clerks, agency members, CPWM officers, and other denominational entities who request them shall have electronic or paper copies of Presbytery minutes distributed to them. The minutes shall include a directory of ministers, probationers, church (with location), session clerks, agency personnel and the name of the church moderator for all churches without an ordained Cumberland Presbyterian pastor. Electronic copies shall be made available within 60 days from the stated meeting for those requesting that medium of distribution. Paper copies of minutes will be printed and mailed annually to include all meetings within that year.
  - 3.40 RECORDING CLERK: The recording clerk shall be elected for a three-year term and may serve additional terms. The recording clerk may or may not be a member of the Presbytery. The recording clerk shall record the minutes of the meetings and assist the stated clerk in preparing the minutes for printing.
  - 3.50 TRUSTEES: The members of the Board of Finance shall be the trustees for the Presbytery. The trustees shall be the legal agents of the Presbytery and shall act in that capacity when so directed by the Presbytery.

#### 4.00 AGENCIES

- **4.10 DATE, TIME, PLACE OF REGULAR MEETING:** All standing agencies of the Presbytery shall convene for their regular meeting at 9:00 a.m. six (6) Saturdays previous to the regular meeting of Presbytery, at the host church.
- **4.15 AGENCY RESPONSIBILITIES:** For agency responsibilities not covered in these standing rules, refer to the "Presbytery Manual of Operation," approved by the 1988 General Assembly, and published by the office of the Stated Clerk of the General Assembly.
- **MEMBERSHIP BALANCE:** In electing members to Presbyterial agencies, care should be taken to maintain approximately a fifty-fifty balance of ministers and laypersons. There should be an appropriate male/female ratio and a fair geographic representation.
- 4.25 REPORTS OF BOARDS AND AGENCIES: Reports of all boards and agencies shall be submitted to the stated clerk no later than four (4) Saturdays previous to the regular meeting of Presbytery.
- 4.30 BOARD OF MISSIONS: The board shall consist of nine members in three staggered terms. The president of the Regional Cumberland Presbyterial Women's Ministry shall be an advisory member of this board.
- 4.31 TERM OF OFFICE: The term of office shall be for three years, and members may not serve more than three consecutive terms.
- 4.32 **RESPONSIBILITIES:** The Presbyterial Fellowship and the Regional Cumberland Presbyterial Women's Ministry will be under the supervision of this board and shall channel their reports to the Presbytery through it. The board will maintain a file of all pastoral contracts, including both stated supply and installed relationships. The board will appoint moderators for all sessions not served by ordained Cumberland Presbyterian Ministers. For other responsibilities refer to the "Presbytery Manual of Operations," Section 5.25.
- 4.33 Any commission to install pastors must include at least one member from the Board of Missions.
- 4.34 Upon the closing of a church in Covenant Presbytery, the session clerk of the closed church is to be responsible to forward a complete membership roll of that congregation to the session clerk of the church specified to have the members attached to it.
- 4.35 BOARD OF CHRISTIAN EDUCATION: The board shall consist of nine members in three staggered terms.
- 4.36 TERMS OF OFFICE: The term of office shall be three years, and members may not serve more than three consecutive terms.
- **4.37 RESPONSIBILITIES:** The board shall be responsible for planning, promoting, and conducting the Presbyterial camping program, including retreats and conferences for all ages.

The board oversees sponsoring the ongoing youth fellowship program in Covenant Presbytery and encouraging the youth programs in the local churches.

The entire Christian Education Program of the congregations of Covenant Presbytery should be of concern by the board as they plan workshops, seminars, etc. to assist and encourage the local churches.

- BOARD OF FINANCE: The Board of Finance shall consist of nine members in three 4.40 staggered terms.
- TERM OF OFFICE: The term of office shall be for three years, and members may not 4.41 serve more than three consecutive terms.
- PRESBYTERY BUDGET: The Presbytery budget shall be a percentage of the current income received by the churches to be equal to the proposed budget. Income is the total 4.42 amount that is given through the church and Sunday school treasuries. Exemptions are:
  - 1. Money raised by the Youth Fellowship, CPWM, Men's Fellowship, and other auxiliaries of the church.
  - 2. Memorial gifts.
  - 3. Money that is borrowed by the church.
  - 4. Gifts that are designated by the donor for a specific purpose such as the purchase of an organ.
  - 5. Building fund money that goes toward the erection of a new sanctuary, church addition, or manse.

Regular maintenance that does not produce additional space, including remodeling, is not exempt.

Churches shall remit payments on apportionments to Presbytery on a monthly basis. Churches experiencing circumstances preventing timely payment of assigned percentage, shall contact the Board of Finance for possible assistance and to allow the board sufficient information for planning purposes.

- 4.42.1 COVENANT PRESBYTERY NEW CHURCH DEVELOPMENT FUND: This fund shall receive all proceeds from property sold by Covenant Presbytery. Expenditures from this fund shall be restricted to grants made to official NCD projects within Covenant Presbytery for the purpose of purchasing property and/or building programs. Available funds in the account, not in immediate need, may be loaned as an "on demand loan" to congregations within Covenant Presbytery for building and/or remodeling.
- RESPONSIBILITIES: The Board of Finance and their successors in office shall be the 4.43 trustees of the Presbytery.

The board shall encourage the churches to give full support to the Presbytery and Synod budget and the Denominational "Our United Outreach" (OUO).

The board, in cooperation with the Board of Christian Education and the Board of Missions, shall plan, publicize, and implement seminars on stewardship, and utilize other means to develop good stewardship practices within the congregations of the Presbytery.

The board shall be the agency responsible for the maintenance of the Presbytery's physical assets such as real estate, office equipment, etc.

The board shall oversee the program of ministerial aid to needy ministers and minister's widows.

The board shall receive the proposed budgets of the other agencies, amending them as necessary, and submitting one unified budget to the Presbytery for action.

The board shall receive loan applications from churches in the Presbytery, making recommendation to the Presbytery concerning these requests.

All requests to the Presbytery for additional funding beyond the approved annual budget shall be directed to the Board of Finance for review, determination, and recommendation to Presbytery at any subsequent meeting.

(In an emergency the Board of Finance shall be endowed with the authority and responsibility of funding from surplus funds, the needs created by any such emergency. - action of Presbytery 4/7/01)

- COMMITTEE ON MINISTRY: The committee shall consist of nine members in three staggered terms. The committee shall include both ministers and laypersons with at least 4.45 two members being elders.
- TERM OF OFFICE: The term of office shall be three years, and members may not 4.46
- RESPONSIBILITIES: The committee shall direct and nurture persons in preparation for the ministry. Those considering becoming candidates for the ministry shall be interviewed by the committee prior to their appearance before the Presbytery. 4.47

The committee also has responsibilities relating to the persons and ministries of the ordained ministers of the presbytery.

Any contractual pastoral relationship in Covenant Presbytery who is not an ordained CP minister or who is not an approved candidate for CP ministry should meet with and /or communicate with the COM prior to filling the pulpit.

There is an extensive description of the duties and responsibilities of the Committee on Ministry in the "Presbytery Manual of Operation," Section 5.4.

- JUDICIARY COMMITTEE: The committee shall consist of nine members in three 4.50
- TERM OF OFFICE: The term of office shall be three years, and members may not 4.51
- RESPONSIBILITIES: The committee shall review annually the session records of the churches and report its findings and recommendations to the presbytery. The session clerks shall send the session records for the previous year (or a certified copy) to the 4.52 Judiciary Committee at the time and place specified by said committee.

The committee shall study all questions coming before the presbytery by appeal, dissent, or protest, and advise the presbytery on their legal and constitutional aspects. The committee shall make rulings on such judicial questions as are referred to it.

The committee shall impose discipline when a minister acknowledges to the Judiciary Committee an error or offense and consents to the discipline proposed by the committee. If the minister acknowledges the error or offense, but does not consent to the discipline, the Judiciary Committee must refer the matter back to the Disciplinary Commission.

The committee shall hold a hearing (following the directions set forth by the General Assembly) to determine guilt and, if appropriate, impose discipline in those cases where the minister does not acknowledge guilt and consent to discipline. The committee shall report its actions to presbytery. (This is a report only, not a recommendation to be voted upon by presbytery.)

The committee shall conduct a supplemental hearing upon a minister's request if new evidence is discovered. After a hearing, the committee may restore a minister who has been suspended or deposed if he or she meets the criteria of Rule 3.415.

The committee will hear and decide appeals from sessions under the presbytery's jurisdiction, and give a report of appeals to the presbytery.

- **4.55 HERITAGE COMMITTEE:** This committee has been dissolved and will be reactivated if the need arises.
- 4.60 <u>COMMITTEE ON NOMINATIONS:</u> The committee shall be composed of six (6) members in three staggered terms.
- 4.61 TERM OF OFFICE: The term of office shall be three years and members will not be eligible to succeed themselves. Members of this committee may NOT serve on the Permanent Nominating Committee and other agencies concurrently. Members of this committee shall not be consecutively nominated to another agency. A member appointed or elected to fill the unexpired term of another person shall be eligible to serve a three-year term after completion of the unexpired term. The members should include at least one (1) minister and two (2) lay persons.
- 4.62 RESPONSIBILITIES: The committee shall make nominations to the October meeting of Presbytery: names to fill all vacancies on Presbyterial agencies, commissioners to General Assembly and their alternates, youth delegates to General Assembly and the alternate, delegates to Synod and their alternates, and youth delegates to the Cumberland Presbyterian Youth Conference (CPYC) and their alternate.

The Committee on Nominations should be especially sensitive to the need for including fair representation on all agencies and in all positions. (See standing rule 4.20.)

# 4.63 COMMISSIONERS TO GENERAL ASSEMBLY AND DELEGATES TO SYNOD: Election of General Assembly commissioners: The Presbytery shall elect one minister commissioner and one elder commissioner for every 1,250 active members on its roll as its commissioners to General Assembly. See Section 9.2 of the Cumberland Presbyterian Constitution.

The election of commissioners to General Assembly will be as follows: three (3) commissioners on the part of the ministry and three (3) commissioners on the part of the elders shall be elected. Three (3) ministers and three elders shall be elected and listed in a 1, 2, 3 order to serve as alternate commissioners in the event any of the principle commissioners are unable to attend General Assembly.

The election of delegates to Synod will be as follows: three (3) delegates on the part of the ministry and three (3) delegates on the part of the elders shall be elected. Three (3) ministers and three (3) elders shall be elected and listed in a 1, 2, 3 order to serve as alternate delegates in the event any of the principle delegates are unable to attend Synod.

Reports from the commissioners to General Assembly and the delegates to Synod shall be given at the fall meeting of Presbytery.

4.65 <u>DISCIPLINARY COMMISSION:</u> The commission shall be composed of five (5) members elected on staggered terms.

4.66 TERM OF OFFICE: The term of office shall be three years, and members may not serve more than three consecutive terms.

RESPONSIBILITES: The commission shall receive complaints made in writing from the victim or a person with reliable and compelling information or from the stated clerk of presbytery who has received the written complaint from one of the above persons. 4.67

The commission shall conduct an appropriate investigation of any written complaint. The commission shall not decide innocence or guilt. They investigate to determine if there is enough evidence for a hearing.

If the Disciplinary Commission, upon investigation, finds no basis for the charges, it shall close the matter and report that action to the accused, the complainant, and the Judiciary Committee.

If the commission finds that there are grounds to believe that an offense was committed by the accused, and the accused acknowledges the error or offense and gives evidence of a sincere effort to correct the matter, the commission shall so report to the Judiciary Committee and recommend appropriate disciplinary action.

If, upon investigation, the Disciplinary Commission determines that "there are grounds to believe that an offense was committed by the accused," they will refer the matter for a hearing before the Judiciary Committee. At this time, the commission should (1) appoint 1-3 members to represent the Disciplinary Commission in the hearing process (2) make a complete report of the investigation to the Judiciary Committee.

If the charges concern matters of potentially serious consequences, the Disciplinary Commission may at any time place limitations on the person's ministry or suspend the person from any position of ministry until the conclusion of the hearing and of any appeals.

If necessary, the Disciplinary Commission may appeal a disciplinary decision of the Judiciary Committee.

The commission may informally counsel a minister if there is an unwritten complaint against him or her.

#### **INSURANCE COMMISSION:** 4.70

RESPONSIBILITES: The commission shall deal with all presbyterial insurance needs 4.71 and transactions including pastoral insurance. 4.72

# 5.00 OPERATING GUIDELINES

- FINANCIAL REPORT: The treasurer shall prepare a detailed annual report at the end of each fiscal year (calendar year), quarterly reports during the fiscal year, and such supplemental reports as the agencies of the Presbytery may need. The treasurer shall 5.10 present the financial reports for an annual audit by a three person audit committee appointed by the Board of Finance each year.
- MEMORIAL ROLL: A memorial roll of deceased ministers and elders shall be carried in the Presbytery minutes each year. The stated clerk shall purchase a one hundred dollar Patron Membership in Theological Education in the name of each deceased minister. 5.20 Also, the same patron membership is to be purchased for each deceased elder who has served as moderator of Covenant Presbytery. The certificates for the patron memberships shall be presented to the families of the deceased (or representative of the family) at the next regular meeting of Presbytery.
  - PRESBYTERY YEAR: The Presbytery year shall follow the calendar year, January 1 5.30 through December 31.
  - NEW BUSINESS: All resolutions, memorials, and other items of new business must be presented prior to the noon recess of the meeting of Presbytery. 5.40
  - CONDUCT OF MEETINGS: All meetings of the Presbytery shall be conducted according to the Rules of Order of the Cumberland Presbyterian Church. Any case not covered by these rules shall be governed by the current edition of Robert's Rules of 5.50
  - INFORMATION REPORT: A form for churches to submit information needed by the agencies of the Presbytery will be available at the April meeting each year. The session clerk shall send this information to the stated clerk's office by August 1st each year. 5.60

Your Committee on Ministry submits the following report and recommendations:

Candidate Brad Henson met with the Committee on Ministry. Brad continues to serve as stated supply at Woodlawn C P Church. He has a Master of Arts from The Southern Baptist Theological Seminary and a Doctor of Ministry from George Fox University. ## Appendix M Commission to Close Vaughn's Chapel Report

To: Covenant Presbytery in session with Chandler CPC, March 16, 2024.

The Commission to Close Vaughn's Chapel submits the following report and recommendations:

March 13, 2024

To Members of the Board of Missions of Covenant Presbytery:

At the request of the board at our February 3 meeting, I have begun the work of closing the ministry of the Vaughn's Chapel congregation as chairperson of the commission that is being recommended to presbytery. As the session had already made plans to hold their final service on February 25 and were seeking immediate help and direction from Presbytery, I felt it essential that I begin the work before the March 16 presbytery meeting.

I contacted Nancy Barlow, an elder and member of the congregation her entire life of over 80 years, and I met her at the church on Saturday, February 3 after our meeting.

We met at the church, and she shared what the session members had experienced that led them to the difficult decision to close. She was seeking direction on proper direction for the congregation to cease their function as an active congregation in Covenant Presbytery. She walked me through the facilities, and we discussed next steps for the body – for ending active ministry, disposal of property, and transfer of assets to Covenant Presbytery.

I discovered that Bro. Wendell Ordway has been in very poor health since early fall, that he has been unable to fill the pulpit or serve as moderator of the congregation since that time. After our meeting I made a pastoral visit to Bro. Wendell and his caretaker, making no mention of the session's decision, leaving it to the elders to make that announcement on Sunday, February 4. The session asked me to guide them in the steps moving forward, and we felt it most appropriate to hold a session meeting, while I served as moderator for the purpose of presbyterial representation.

We met on Sunday, February 10, with 3 of 4 elders present (Nancy Barlow, Brenda Gingery, and Harry Fuller), and the fourth on speaker phone from Alabama (John Case). I discovered in talking with them that the elders had made a very difficult decision, but a very sober decision. While the immediate precipitating event was a water pipe burst, what they painfully accepted was that they were an aged congregation with the inability to maintain the facilities, with little hope of future growth. One elder lives over an hour away from the church, one in Paducah, one in Gilbertsville, and one is experiencing rapid health decline from a chronic condition. The congregation had 8 in attendance the Sunday before, and none were under 70 years old. After asking if they were seeking help in securing pulpit supply beyond February 25 to continue, it was evident that they had come to peace with their timeline. I offered to organize a service of closure and to perhaps involve former pastors, and I again I found that they were at peace with the decision they felt they had to make. The pulpit for their final service would be filled by a 91-year-old retired Baptist minister who had filled the pulpit for them since Bro. Wendell became unable to do so, a minister who was a member of Vaughn's Chapel as a child, and they simply wanted to worship together and leave for one final, difficult time. 20 people attended the final service - which included family and friends coming to support those members who were experiencing the painful closure that day. All present for the final service signed the guest book that sat in the foyer.

I met again with the session on Saturday, March 9. In consultation with Elder Raymond Nelson from the Board of Finance, I have given them direction, and the summary of our actions to this point are as follows:

1) Tools of ministry, furniture, certain décor, and items used in ministry have been made available to the families who donated them or to the families of those in whose name they were dedicated. Mrs. Barlow and other members have worked diligently to contact those family members and even made the effort to deliver hymnbooks to families in whose names they have been dedicated.

A list of all items that have been distributed has been preserved. Of particular note:

a) The kneeling bench and baptismal font were taken by the active member who constructed them.

- b) The altar cross and candlesticks were returned to the family of those in whose name they were dedicated.
- c) An antique lamp in the sanctuary was given to the great granddaughter of the donor.
- 2) Mrs. Barlow will continue to pay utility bills for the church and parsonage until such time as the church is sold or transfer of ownership to Covenant Presbytery occurs.
- 3) We have secured mowing services to keep the grounds in good condition during this period of transition.
- 4) As the transfer of property will not occur before that time, the session approved the use of the church facilities for a memorial service on April 6.
- 5) The session has been the caretaker and beneficiary of a large endowment and entrusted with the dispersion of the interest from that endowment as a scholarship. We discussed means by which that ministry and intent could continue in perpetuity. The session seeks to transfer those funds to Covenant Presbytery after Presbytery votes to accept such funds for the specified purposes.

Recommendation #1: That Covenant Presbytery accept the endowment funds from the Vaughn's Chapel session for the E.M. Bailey Scholarship Fund and agree to administer those funds as the E.M. Bailey/Vaughn's Chapel Scholarship in accordance with the scholarship description provided. (See attachment.)

- 6) The session received a financial report from Mrs. Barlow that indicated a checking account balance of just under \$30,000. They also have a CD that will mature in July worth approximately \$15,000. There was a Sunday School Fund of \$728 as of February 25. As there are no immediate structural or repair needs that will put the property at risk during this period of transition, it was my advisement that those funds primarily represented gifts of those currently in the congregation, and the session could make decisions for gifts of those funds to support ministries for which they believed could further the work of the Kingdom. To that end,
- a) The Sunday School Fund was donated to Marcella's Kitchen ministry in Benton.
- b) A donation of \$10,000 was approved and sent to Paducah Cooperative Ministry's Fresh Start Village for homeless women and children.
- c) A donation of \$10,000 was approved and sent to Paducah's Community Kitchen.
- 7) Remaining funds will be retained for property upkeep until such time that another group purchases the property.
- 8) The session expressed a desire to have a permanent memorial marker placed on the property to call attention to future generations to the work of the Kingdom that occurred through the life of Vaughn's Chapel for 126 years at that site. We will seek to have that placed in the area of the flagpole and veterans' memorial at the front of the property. The memorial will be purchased from remaining church funds.
- 9) The elders helped me compile a list of active and semi-active members and contact information for each one. While some already have plans to attend with family or friends and one has made initial plans to become a part of Marion Cumberland Presbyterian Church, it is my attention for the commission and local pastors to conduct pastoral follow-up to make sure that all members feel welcome at area CP Churches or are able to find another place to become active in another congregation.

Recommendation #2: That in lieu of attaching members names to the rolls of another CP congregation to which they have no connection, for a period of one year, Covenant Presbytery give the session the authority to grant a letter of membership status, record of baptism, and profession of faith to each member.

<u>Recommendation 3</u>: That the commission be given the authority to grant letters of dismission upon request from the period of the final meeting of the Vaughn's Chapel session until March 2025, until all members have secured a new church home, or until they are transferred to a CP Church near the church.

- 10) Arrangements are in process to collect and transfer all historical documents and session minutes to the Historical Foundation of the Cumberland Presbyterian Church after the final session meeting and as soon as they can be compiled.
- 11) We are seeking ministries to which items such as dishes, tables, and tools for ministry and fellowship may be donated and used in service. Those who may be interested should contact members of the session, or the commission when transfer occurs.
- 12) It is the desire of the session and congregation to be faithful to the work of the Kingdom. Though they realize that their ability to accomplish significant ministry through their current ministry, they hope that their decision at this time will provide the opportunity for at least two congregations to grow one on the current Vaughn's Chapel property, and one new congregation or rapidly growing congregation that can be supported with the proceeds from the sale of the church building and parsonage.

Recommendation #4: That Covenant Presbytery hold itself accountable to use the funds from the sale of the Vaughn's Chapel property to support only a new church plant or to bolster the ministry of a rapidly growing young congregation in need of support, as recommended by the Board of Missions.

There is a group in the area that is renting space for their new congregation. We have had some contact, though interest seems to be minimal. I will continue to pursue that conversation. Mrs. Barlow is in possession of the deed to the property.

Recommendation #5: The session of Vaughn's Chapel shall be considered active until July 31, 2024. If a sale of the property to a congregation seems to be on track before that time, the deed shall be directly transferred from the elders to the purchasing group, with funds from the sale being transferred to Covenant Presbytery.

Recommendation #6: If the sale of the Vaughn's Chapel property has not been completed or initiated by July 31, 2024, the deed to the property shall be transferred to Covenant Presbytery, as well as remaining funds in the account designated for the upkeep of the property, and responsibility for payment of utilities and upkeep expenses shall be the responsibility of the commission in coordination with the Covenant Presbytery treasurer.

13) The commission needs to have the authority to transfer the property without another meeting of presbytery.

Recommendation #7: That the commission approved by Presbytery have the authority to list the property with a realtor, enter into a contract for sale, and properly transfer the property on behalf of Covenant Presbytery.

Recommendation #8: That the Moderator, Stated Clerk and/or Commission Chair be approved as appropriate signing agents of Covenant Presbytery to make transfer of such property.
